



Call for Application Small Grant for ANROEV Member Organizations in Asia FY 2024/25

1. Background and Objective

ANROEV will continue to support and strengthen victims and their rights advocacy groups in 2025.

One of the main objectives of the network is to empower victims and their groups to lead, represent, advocate, and negotiate on their behalf. To accomplish this, the network intends to strengthen the capacity of victims' groups by providing them with small grants.

The small grants will focus on the network's key areas of work for victims of occupational safety and health (OSH) issues. These areas include providing training and resources, grassroots organizing, mobilization, and empowering the voices of occupational safety and health accidents victims. Additionally, the grants will support actions related to diagnosis and medical treatment, as well as the production of short videos that highlight the stories and struggles of victims, similar to the "Victims Diaries" developed in previous project cycles. The grants will also assist labor advocates in gaining a deeper understanding of the OSH situations relevant to their respective projects.

2. Funding

ANROEV, through the OSHE Foundation International, will provide small grants of USD 3,000 each for eight (8) member organizations in the region. This is part of its solidarity and support in promoting and upholding the voice, rights, and movement of OEHS victims across the region. The network aims to fund diverse projects covering various countries, sub-regions, and issues.

3. Project Scope and Reporting

The grant is intended for

- OSH victims and communities affected by asbestos/pesticides/chemicals/waste hazards
- OSH victims and communities affected by factory fire / structural collapse
- Gender-based violence (GBV) victims
- OSH victims in the electronics sector
- OSH rights issues related to the Belt and Road Initiative (BRI)





The activities should lead to one of the following types of project outputs and results:

- Grassroots organizing and new network building, advocacy, and mobilization of OSH victims; public and social media campaigns, legal fights for compensation and justice, etc.
- Capacity-building and awareness-raising activities (including training among victims) group members).
- Medical support to victims' groups, need-based diagnosis, treatment, and medicine support to victims' groups.
- Printed or online publications and campaign video production on OSH victims' issues.
- Development of organizing scope, increase in membership, and collective bargaining on OSH issues, movement building, legal compensation for victims, or improvement of working conditions

The project must be implemented between 01 Feb 2025 and 15 June 2025. Activity reports, financial reports, and receipts should be submitted to the ANROEV coordinator/OSHE. Once projects are completed, the network coordinator will compile the highlights based on the reports from the groups and share them with the network.

4. Application Process

All ANROEV members in the Asian region are invited to apply for this small grant.

Applicants must submit a proposal that includes objectives, activities, expected output, outcome, and budget.
